Jobs of Hope, Inc. was founded in 2013 for the purpose of providing support for Colorado men seeking to reenter the community and obtain a better quality of life. We are a faith-based reentry program focused on assisting justice-involved clients to find success though employment, financial acuity, permanent housing, and mind/body/spirit wholeness.



Greetings and welcome to our 2023 Annual Report. I am immensely proud of the volunteers and staff of Jobs of Hope. 2023 was a challenging year but also a year of profound opportunity. Our team responded to financial and program challenges with determination and purpose. We know that 2023 is just the start of the greatest years yet at Jobs of Hope.

In 2023, we accomplished quite a lot. First and foremost, we chipped away, honed, and shaped our services to produce our Continuum of Care model. Addressing the current state of re-entry services in Northern Colorado, Jobs of Hope sees the need for coordinated, integrated services in order to minimize confusion and conflicting case management when there are multiple service providers involved. Jobs of Hope brings our treatment services under "one roof" so that all team members and departments can collaboratively respond to changing client needs. We call this process Dynamic Case Management, and we are seeing success with our clients as they deal with one organization for all services.

We also honored the passing of our dear friend and board member Rick Hartman. Mr. Hartman was a key leader in the Northern Colorado Toys for Tots organization, as well as a key innovator for the RoundTable curriculum, currently in use at many organizations. We plan to honor Mr. Hartman's dedication and commitment formally in 2024.

For the near future Jobs of Hope will continue provide hope and purpose to clients exiting the justice system. At the same time, we are exploring how to provide services to female clients, how to implement new curriculum for purpose development, and how to implement increased access to mental health care. 

JOBS OF HOPE HISTORY

OUR HISTORY

Jobs of Hope, Inc. (JOH) was founded in 2013 to provide support to gangaffiliated men who wanted to exit the gang lifestyle yet needed support to reenter the community. Pastor Greg Ehlert, the former teaching pastor of Cornerstone Community Church in Greeley founded the organization. He worked with former gang member and Fresno, CA nonprofit leader Vanna In to launch Jobs of Hope. Since its inception, JOH has had the pleasure of serving over 450 men, many of whom have been incarcerated. Seeing that clients were often dealing with barriers due to incarceration, JOH began to pivot to re-entry services. By 2020, JOH officially transitioned to become a re-entry program, working with men exiting the justice system.

The House of Hope open to provide housing assistance to clients. The facility is a 14-bed facility, operated with a sober-living framework.

Current Executive Director, Dan Ordaz, is hired. Jobs of Hope formalizes the Continuum of Care model and Dynamic Case Management practice.

- 44% of enrolled clients found permanent housing while enrolled in Jobs of Hope
- 87% of housed clients maintained their housing for 3 months or longer



ADDITIONAL BEDS. ADDITIONAL CITIES

As Colorado prisons, jails, and court systems become overrun with individuals needing adjudication, Jobs of Hope sees the opportunity to develop additional sober living transitional housing facilities in Weld County. Jobs of Hope also envisions outreach to surrounding Northern Colorado counties.

Jobs of Hope is not content to stand still. There is still a need in Northern Colorado for more housing, more classes, and more services to reach justice-involved clients. As we look to the next 5 years, Jobs of Hope will undertake 3 major initiatives.



WOMEN'S SERVICES

Jobs of Hope desires to provide the same excellent services to female clients as we do to our men. We visit with justiceinvolved female clients monthly. Their urgent cry is the same: services are needed for the unique circumstances of justiceinvolved female clients. These potential clients intersect urgent groups of services: justice-involvement and housing, justiceinvolvement and domestic abuse, justiceinvolvement and pregnancy services, etc. The mindset, trauma situations, and physical concerns of justice-involved female clients require unique solutions, that Jobs of Hope is ready to study, test, and implement.


Andrew Clawson


