#### Who We Are

Jobs of Hope is a faith-based re-entry program, serving clients in Weld County since 2013. Our mission is to restore hope and transform the lives of individuals involved in the justice system. Our program focuses on case management, mental health, education, and counseling resources.

We support our clients in developing goals for employment, financial readiness, permanent housing, and mental/spiritual wholeness.

## Eligibility

- Clients 18 years of age or older.
- Released from incarceration within the last 3-5 years.
- Previous or current gang affiliation and/or criminal conviction that inhibits their ability to obtain employment.

## **Expectations**

Participants are asked to:

- Commit to leaving behind their old way of life.
- Refrain from using drugs, alcohol and substances that impede their ability to obtain or retain employment.
- Act in a professional and respectful manner in how they talk and interact with others.

#### **Our Services**

CASE MANAGEMENT



Our Reentry Case Manager meets with participants one-on-one to create a reentry plan to meet both short-and long-term employment, housing and personal goals in a supportive, non-judgmental environment. The Case Manager also collaborates with community partners to connect program participants with the resources they need to thrive.

#### MEN OF VALOR LIFE SKILLS PROGRAM

Derived from Global Priority Solutions, the Men of Valor program creates personal transformation through the exploration of character values at weekly round-table meetings.

The goal is for men to see themselves as Men of Valor and share their newfound hope with their children, spouses, colleagues and friends. Most of all, the goal is for those who complete the program to become a beacon of hope for future participants.

## RELAPSE PREVENTION DISCUSSION GROUP

Relapse Prevention Discussion Group is an addiction program that creates an environment where individuals can explore what it means to live in a place of recovery and hope. Participants explore the concepts of healthy boundaries, detrimental attitudes, and coping skills to stay substance free.
